- Call to Order: Meeting called to order at 4:30pm. Present: Chairperson Kim Baker, Roland Garland, Richard Hanson, Karen Ponton, Dave Reilly, David Hughes (Alternate).
- II. **Approval of Minutes**: Motion by K. Ponton, seconded by R. Garland that: The Minutes of July 30, 2015 and August 20, 2015 be approved as written. Passed unanimously.
- III. Old Business: Proposals for Town House Rehabilitation/Reuse Plan: The Commission reviewed the following proposals for a Rehabilitation/Reuse Plan for the Old Town House:

•	Christopher Williams, Architects	\$ 8,000
•	Alba Architects, LLP	10,900
•	Warren Street Architects	9,000
•	SMP Architecture	7,500

- R. Hanson questioned whether architect services are really needed when perhaps some of the work could be done by a general contractor or even the Town Code Enforcement Officer. K. Baker reminded the Commission that the major reason for using an architect with expertise in historic preservation is to develop a Master Plan that will guide the rehabilitation of the Old Town House. The intent is to avoid a piecemeal approach.
- R. Hanson also raised concern about high or unnecessary costs, hidden fees and extra charges. K. Ponton said she believes the Commission recognizes its responsibility to use all grant, donation and Town monies carefully, judiciously and wisely.

After much discussion and point-by-point comparisons, the Commission narrowed its focus to two (2) proposals worth additional consideration: Christopher Williams, Architects and Alba Architects, LLP. Commission members then composed and signed letters to each of these firms. (See attached). Motion by K.

Ponton, seconded by R. Hanson, that: <u>The Chairperson be directed to mail these letters written by the Commission to the two (2) designated firms. Passed unanimously.</u> The Commission will discuss the revised proposals at its October 15 meeting.

K. Baker will also send letters declining their proposals to Warren Street Architects and SMP Architecture.

IV. Adjournment: Motion by K. Baker, seconded by R. Garland, to adjourn at 6:50pm. Passed unanimously.
