July 6, 2017 Minutes

- I. Call to Order: Meeting called to order at 5:30pm. Present: Chairperson David Reilly, Roland Garland, Karen Ponton; Absent: Richard Hanson, David Hughes, Nancy Sapack (alternate); Guests: Mae Williams (Grant Consultant), Amy Dixon (NHDHR Grants Coordinator), Amy Reardon.
- II. **NHDHR Model Survey Grant**: The Commission discussed at length the next steps towards implementing the model survey, especially how to get the work done given the limited availability of the consultant and limited pool of volunteers. Major points follow.

The first step is to develop a list of historic properties that are important to the people of Center Harbor. Consensus was to use the Commission's current working draft of 72 cultural and historical resources in Center Harbor, dated 2016. (See attached). This draft includes 22 resources inventoried in 1983 as part of the Town Master Plan, plus resources later identified by the Commission and others. M. Williams shared a simple inventory form that she recommends be used to record information on each resource. This form could easily be completed by property owners, volunteers or others familiar with the property. Information on each property would eventually become part of a geo-database and used to create an interactive GIS map of the Town's historical resources. The minimal amount of required information is the address of each resource and a photograph, which can be easily obtained from the tax assessor's maps on the Town website. M. Williams will email K. Ponton the inventory form so that Commission members can begin to enter this information. R. Garland will see about contacting Historical Society members who own historic properties to engage them in the process.

It was stressed that the entire inventory form does not have to be filled out to be helpful. Information can always be added. Also, the inventory form will be used only to gather information for the survey; the information is not for tax purposes or for reporting to the State.

The mapping process will require software. The goal is to eventually have the map of historical resources available online. A. Reardon is very familiar with ARCHMAP, which is available for purchase from an ESRI company. It is possible

the Town may already own this software; she and D. Reilly will check with Aimee Manfredi-Sanschagrin in the Town Planning and Zoning office. It is also possible that the Lakes Region Planning Commission may have mapping software that the Commission could use. Also, there is free software called QGIS. A. Reardon added that it would be very easy to teach a volunteer(s) how to enter data for the mapping. She also offered to contact PSU to see if any students might be available to help with GIS mapping. Special GIS mapping equipment is not necessary if the address of the historical resource is known.

Another step is to gather historic maps of the Town to use as layers for GIS. A high resolution 1860 map is needed, which may be available through the *Library of Congress* website. D. Reilly has a framed 1892 map that M. Williams may be able to scan. She also needs USGA maps. R. Garland will check to see what maps the Historical Society may have, and email these to M. Williams.

A bibliography of the Town is also needed. M. Williams offered to share the bibliographic information she already has, but it may be incomplete and not have all available written histories of the Town. D. Reilly has a Town history written by a cobbler and he will get a copy to M. Williams. She already has the Town history written by the Historical Society. The Commission knows of no other histories.

M. Williams will email Commission members a copy of the latest daft of the model survey manual.

Timeline for completing the tasks listed above is December 2017.
