Fogg Hill Conservation Project

Carl Johnson, surveyor, is doing a preliminary survey work now and will let LRCT (Lakes Region Conservation Trust) know if more survey work will be necessary.

A mailing from LRCT to area residents will be going out soon to inform residents about the project and also encompass a request for donations.

More time is needed to finalize the purchase of the property by LRCT. Tom Howard, LRCT's real estate agent for the transaction, is working on extending the April 30, 2013 date.

There was discussion about:

- hope for future conservation easements from residents living in the area between Fogg Hill and the Meredith conservation land.
- including language in the Fogg Hill Easement regarding wind turbines.

Conservation Plan

It was agreed by all present that the draft Conservation Plan should be reviewed when all Conservation Commission members are present.

NEW BUSINESS

Maureen brought to the attention of the Commission, an initiative by Lakes Region Planning Commission (LRPC) to revise their Regional Plan vis a vis the Granite State Future approach. This approach has drawn the attention of the Center Harbor Select and Planning Boards.
